Ordinance – Dental Hygienist

1. Scope: A **Dental Hygienist**, scales, cleans or polishes teeth or gives instructions in dental hygiene. He shall work under the supervision of the Registered Dental Surgeon.

2. Eligibility for Admission: A candidate should be at least 17 years of age at the time of admission or within 3 months of it and should be medically fit to pursue the course.

The candidate must have passed 10+2 or equivalent course with Science subjects i.e. Physics, Chemistry and Biology from a recognised Board or University.

3. Admission : Admission is made on merit basis. The merit list is prepared based on written test. Admission is made only in 1st year and is made once in a year.

4. Program Duration: Two years

5. Annual Intake 20 Students per year

6. Medium of Instruction: The medium of instruction for the subjects shall be English only.

7. Attendance:

- a) A student is normally required to attend all the lectures , practical, demonstration and clinics of every subject as also the curricular and co-curricular activities..
- b) A student must have minimum 75% attendance in lectures, practical, demonstration and clinics of each subject for appearing in the examination.
- c) In special circumstances, short fall in attendance can be condoned on case's merit to the extent of 5% by the Principal. If the short fall is more than 5 %, the Principal may recommend on case's merit to the Vice Chancellor for condonation. The order of Vice Chancellor shall be final.

8. Syllabi: The syllabus of the course shall contain subject wise details as prescribed by Dental council of India duly approved by Board of Studies / Faculty board. It shall be published separately. All changes and modification shall be incorporated as and when notified by Dental Council of India on immediate basis.

9. Program Curriculum: The program is based on the learning experience by way of practical in labs and by demonstration on working chair in clinical area. Hand on experience is also extended in the clinics. The Course delivery is combination of theory and practical aspect and broadly organized as under –

10. Examination:

- a) At the end of each academic year student shall be evaluated by way conducting examination.
- b) In an academic year two examinations will be conducted – main and supplementary. The supplementary examination will be conducted with in the 2 months of declaration of main examination result.
- c) For each subject evaluation shall comprise of theory, viva and practical.
- d) The duration of theory examination shall be three hours and question paper shall uniformly represent the syllabus. The examiner for theory examination shall be not below the Reader.
- e) The viva and practical examination shall be conducted by a panel of three examiners and shall include one external and one internal examiner- Associate Professor (Reader) from periodontics and third examiner (Internal) Tutor involved in teaching – Dental Hygienist Course.
- f) Any candidate who fails in one or more subject in the primary examination (first year) is permitted to go in the next higher class, provided the HOD has given the certificate of required training before appearing in supplementary / subsequent examination.

12. Qualifying Standards

- A student must score minimum 50% in theory including viva and practical individually for clearing a subject.
- A student fail to secure minimum 50% in any one or both shall be declared fail in the subject and shall be required to reappear both in theory and practical of the subject.
- A student shall have maximum two attempts to clear a subject. In case he fails to clear, he shall be required to appear in all the subjects.

13. Promotion Rules

A student will be allowed to take up final year examination, if he has cleared all the subjects of 1st year.

A student does not clear even after availing two attempts of supplementary examination, shall be required to appear in all the subject of that year.

The maximum duration of completion the course shall be four years. After four years student shall be required to take fresh admission in the course

14. Grace Marks: A student can be awarded 'Grace Marks' not exceeding a maximum 5 marks either in theory or practical or both. However, the grace marks shall not be part of the grand total.

15. Result

- The result of a student shall be declared for each examination which will indicate the status of his performance in the respective examination.
- The result shall be updated based on outcome of his/ her appearing in the subsequent examination.
- A student who secure 75% marks or above in a subject shall be declared to have passed the subject with distinction subject to he has passes in all other subjects in first attempt.

16. Award of Certificate:

Students who have successfully completed the course shall be granted a DIPLOMA subject to the approval of DCI.
